Whistle blower says she 'didn't do enough'

ST. PAUL — After she made her First Communion as a little girl, Jennifer Haselberger was distraught to learn the Catholic church had no saint Jennifer, and she had no saint to call her own. So her mom opened up a book and pointed to Joan of Arc.

"There. That's yours," she said.

Years later, Haselberger is in a fight of her own after going public with claims that archdiocese leaders in St. Paul mishandled allegations of clergy sexual misconduct. Turns out, Haselberger may have borrowed a little bravery from the headstrong French heroine she has long admired.

Haselberger, a former canon lawyer for the archdiocese, took on leaders of the church she loves after she felt her warnings about troubled priests were being ignored, setting off a firestorm in the local church.

Fire deaths have dropped in Minnesota

ST. PAUL — A report from the state Fire Marshal Division shows the number of fatalities caused by fire has decreased over the past 40 years.

State Fire Marshal Jerry Rosendahl says officials are proud of the progress Minnesota has made.

According to the report announced this week, Minnesota has the 10th-lowest rate of fire deaths per capita in the United States — at .93 deaths per 100,000 people.

State officials say devices such as smoke alarms and sprinkler systems have helped lower the number of deaths. Inspection and code enforcement programs targeting hotels, schools and other facilities have also helped.

The report says a total of 50 people died in Minnesota fires in 2012, compared with 56 a year earlier. Cooking continues to be the No. 1 cause of structure fires.

Fines reach nearly \$3K in sunfish over-limit case

ST. PAUL — Little sunfish can be expensive — for anglers who keep more than their limits.

The Minnesota Department of Natural Resources says four men recently pleaded guilty and paid fines of about \$740 each for sunfish over-limits.

Conservation officers checked the men while patrolling Deer Lake near Effe in northern Minnesota. The officers later searched freezers at various locations. They found bags of mostly frozen sunfish from Deer and four other lakes. Three of the five lakes have a 10-sunfish-per-person daily limit, compared with a daily limit on most Minnesota lakes of 20.

The sunfish were seized and the men were charged with 84 sunfish over the legal limit.

Family: 'It hurts us so much'

A passer-by saw the fire at 501 East Vernon Ave. residence just after 8:30 p.m. and called 911. The fire marshal found that the fire began from a power strip in a basement bedroom.

Police said the residents were adults Baranislav Babic, Mejra Babic, Ahmet Babic and Saric in addition to five children, ages 12, 8, 5, 2 and 1.

They have all been at a local hotel since the fire but have to be out by 11 a.m. Thursday. The Red Cross and Salvation Army have assisted them.

"We've been having trouble sleeping ever since we got here," Saric said. "We don't know what we're going to do. First we have to find a place to go."

It has been hard on the children as well. They're used to playing outside, Saric said.

"They're not used to this," she said. "It's like they're in jail looking at four walls."

Sewer and drainage problems had plagued the house for months. Landlord LaMar Boettner said it took all summer to get repairs to the sewer line arranged.

The work was finally done Oct. 17, but another backup occurred the next day and the plumber couldn't find the problem.

The family couldn't use their plumbing, and with sewage backup in the basement causing an odor, Boettner put them up in the hotel.

"It's just something I did because they can't be living in a place where it smells, and it's just not sanitary," Boettner said. "They didn't have the money to pay for the hotel, so I thought that it's the least I can do."

The family had moved into the Vernon residence about 18 months ago. They didn't have renter's insurance at first, but they obtained it six months ago at Boettner's urging, he said.

He saw the family Sun-

day and said it's been difficult for them. With all the sewer problems in the house, the family had rented a carpet cleaner. Boettner offered to pay for that and was able to get them a cashier's check so they could have that money right away to help after the fire, he said.

"Every little bit helps," he said.

Boettner said he also coached the family on how to deal with the insurance company to get assistance for housing and make sure they had a list of their belongings.

He is not sure yet whether he will be able to repair or rebuild the house.

For the family, they said they're not doing well. They lost everything they had.

"It hurts us so much," Saric said. "You just want to cry. That's all you want to do. In a million years you never thought this was going to happen. It just happened to us."

ceed that finish this year.

The team has been working hard, but for Doric, in her first year on a robotics team, it hasn't felt much like work.

"It's a fun atmosphere," she said. "You feel like you are a part of helping and doing something that is productive."

WestRidge Mall donated the empty store space to the team after Grotberg contacted them. He wanted to use the mall because more

members of this team live in Fergus Falls.

Taking part in the competition has been quite the time commitment. Grotberg is at the mall six days a week, about six hours a day during the week and eight hours on Saturday. Doric estimated she spends about 15 hours with the team each week and Sandahl shows up on Saturdays and weekdays when she doesn't work.

But after weeks of hard work, the competition is drawing near. The robot is

95 percent done, according to David Grotberg, and the last few days before the competition will be mostly spent on test runs and final preparations.

There is one more thing the team needs for the competition: loud support.

"The judges will look at how many people we have in our stands cheering for us," David Grotberg said. "The more people that make it down to the competition to cheer for us, the better."
