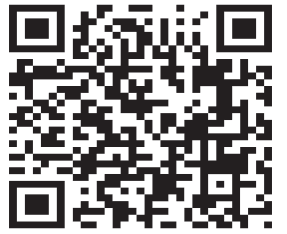

Veterans of the Civil War exhibit opening

A new exhibition entitled "Veterans of the Civil War" opens on Friday, Feb. 14, 4-7 p.m. at the Otter Tail County Historical Society Museum.

Created and installed by OTCHS staff and volunteers, this display focuses on the contributions Civil War veterans made to Otter Tail County. More than 1,000 veterans came to call Otter Tail County home. The exhibit explores the impact some of these individuals made to the social, agricultural, educational, business and political development of the county. It also touches on why the war happened, what life was like for the average soldier and includes a brief timeline

of the war. With over 85 photographs, Civil War era artifacts and a recreated campsite, the exhibit will be enjoyed by all ages.

For your enjoyment on opening night, Museum education coordinator Melissa Hermes will present the program "Civil War Knapsack" at 6 p.m. As part of the presentation, county attorney David Hauser will read excerpts from the Civil War journal of E.E. Corliss who later became Otter Tail County's first county attorney.

Heuer: Another child says he was touched, too

conduct and four felony counts of second-degree criminal sexual conduct.

He was then charged in September with felony first-degree criminal sexual conduct and felony second-degree criminal sexual conduct.

He remains in the Otter Tail County Jail.

According to the criminal complaint, Heuer sexually assaulted children when he was volunteering as a fishing guide at Lutheran Island Camp in Henning.

He allegedly inappropriately touched four male victims, ages 8-10.

Additional incidents allegedly occurred with two of the victims on a separate fishing trip, unrelated to the camp, in Aitkin County.

Heuer was placed on administrative leave from the Mille Lacs County Sheriff's Office when he was charged in July.

Heuer also allegedly had sexual contact with another child in June 2009.

According to the criminal complaint, the child's mother contacted authorities in July after they'd seen a photograph of Heuer on the television news, and her son said he had "touched him." The woman reportedly told a detective her son spent lots of time with Heuer a few years ago, at camp and fishing trips. While watching the news, she reportedly asked her son what happened. He became upset and

said, "What do you think, the same thing that happened to the other kids," the report says.

Heuer allegedly sexually assaulted the child at Heuer's residence and once at camp.

The next court appearance for Heuer in both cases is scheduled for March 20, with a jury trial scheduled for March 24.

Running lights don't replace headlights

Question: My car has running lights and I always assumed that meant my rear lights were on as well, but my husband let me know one day as he was following behind me in the fog that my tail lights were not on.

Since then, I have noticed that many other drivers must assume the same thing.

You might want to let them know they need to actually turn on their lights during the day when it is foggy or they risk being rear ended.

I think this is a good idea for an article, thanks.

Answer: Very true. We have been fighting that battle for many years now and I hear about it all the time from people.

I have always taught motorists to drive with their headlights on at all times, even during the day, so they can avoid the whole issue of when to have headlights on.

Even if you think you have headlights on all the time, you might not. Turn them on manually; then

you will know for sure.

Daytime running lights cannot be used in lieu of actual headlights during the times that actual headlights are required to be on.

During those required times of headlights, all the other lights also are required (e.g., tail lights, marker lamps, etc.). Those other lights are not always on when the so-called "automatic" lights are on either.
