

Maynard Carlton Olson, 90, of rural Underwood, died Monday, June 30, 2014, at Lake Region Hospital in Fergus Falls.

He was born Dec. 21, 1923, in Havana, N.D., the son of Ole C. and Ella (Osmundson) Olson. He was baptized and confirmed in the Havana Lutheran Church. He grew up in Havana, moving to Nashua, Minn. when he was 18 years old where he farmed with his parents.

On March 13, 1948, he married Edna Birdell Brubakken at the farm near Nashua. In 1951 he enrolled at Moler Barber College in Fargo. For seven years he barbered in Fergus Falls, later barbering in Underwood for 12 years.

From 1960 to 1970 the family lived on a farm in Girard Township, while he was working in Underwood. In 1974, they sold the farm and moved to Tordenskjold Township east of Underwood where he lived since.

Maynard also drove bus for the Underwood schools for 10 years, and

for 10 years he barbered at the Fergus Falls Regional Treatment Center.

He was a member of First Lutheran Church in Battle Lake and served on various boards. He was also a member of the Battle Lake Senior Citizens. Maynard enjoyed bowling, horse-shoes, playing cards and working with Herford cattle as a hobby.

Preceding him in death were his parents; sisters, Lorraine Hanson and Eleanor Bremmon, and brothers, Francis, Orville, Elven, Sidney, and two in infancy.

N.D. defends same-sex marriage ban in response to lawsuit

FARGO — North Dakota's top leaders have asked a U.S. District Court judge to dismiss a lawsuit challenging the state's ban on same-sex marriage, outlining its legal case for retaining a prohibition that's rapidly disappearing in the U.S.

In a motion filed Tuesday to dismiss the case, North Dakota Solicitor General Douglas Bahr argued that the U.S. Constitution leaves it up to individual states to define marriage.

"This case is really about who decides, not who is right in this im-

portant policy debate," Bahr wrote in the brief on behalf of Gov. Jack Dalrymple and several other top state officials named as plaintiffs in the lawsuit. "Under the United States Constitution, the people of North Dakota decide the definition of marriage for the State of North Dakota."

Seven same-sex couples challenged the state constitution's ban — which voters approved by a wide margin in 2004 — in early June, making North Dakota the final state to see a challenge to such bans. The couples argued that the state's ban unconstitutionally denies them the same rights and benefits granted to couples of different gender.

Since the U.S. Supreme Court struck down the federal Defense of Marriage Act last summer, making married same-sex partners eligible for federal benefits, a string of judges have ruled that state prohibitions outlawing gay marriage are unconstitutional.

In all 23 court rulings on the subject in the U.S. since the federal law was struck down last summer, judges have sided with proponents of same-sex matrimony, according to Freedom to Marry, an advocacy group in favor of gay marriage. Same-sex marriage is legal in 19 states, and there are pending rulings legalizing it in 12 more states, according to the advocacy group.

Old church — free, as long as you haul it away

KRAGNES, Minn. — It's a classified ad much like those seeking a new owner for a cat or a dog.

But the ad running in The Forum of Fargo-Moorhead the past several days is offering something unusual — one old church, free to a good home.

"It cost too much to fix up, not enough members to do it," said longtime Oak Mound Congregational Church member Alvin Swanson, who lives about a mile away from the now-defunct church just north of Moorhead. "We had insurance, but it didn't cover seepage."

The church, built in 1896, had attendance hovering at 30 to 35 people when it finally was forced to close after the 2011 flood.

"I was pretty proud of that," said the Rev. Jo Cassidy-Mahoney, who had been pastor at Oak Mound for about five years when it closed. "Such a beautiful group of people, very dedicated to the church."

At one of the last events held there, Cassidy-Mahoney recalled, one of the keynote speakers referred

to himself as a newcomer — at only 30 years with the congregation.

When the flood hit, even the most dedicated were forced to stay away. Roads to the church were covered in floodwaters, making them impassable for most of the congregation.

As its members did their

worshipping elsewhere, praying for the rest of the valley to be spared, they didn't realize it was the old church they should be praying for.

And it wasn't until the floodwaters receded that they finally got inside it and realized the basement sump pumps had failed, filling it

with 3 to 4 feet of water.

"It had been in the back of our minds, how could we go on," Cassidy-Mahoney said, considering the dwindling numbers in the pews.

The congregation was down to just two Sunday-school-age children. And it had no flood rider on the church's insurance.

Abortions down in MN

ST. PAUL -- The number of abortions dropped in Minnesota in 2013 for the seventh straight year.

The 9,903 abortions is the lowest number since 1974 and a 7.5 percent decrease from the previous year.

Tuesday's Minnesota Health Department report confirms the success of laws that provide abortion information and alternatives, the Minnesota Citizens Concerned for Life anti-abortion group said.

Still, MCCL Executive Director Scott Fischbach said, the abortion rate could have been lower.

"As governor, Mark Dayton has vetoed seven protective measures, at least four of which would have protected women and further reduced the number of abortions last year," Fischbach said. "Dayton's defense of the abortion industry has been at the expense of unborn babies and their mothers, who are nonetheless rejecting the self-destruction, dehumanization and death that result from abortion."

Minnesota health spending slows

ST. PAUL -- Minnesota health care spending

increased by 4 percent from 2011 to 2012, a slower rate than in the past.

The state Health Department reported Tuesday that the most recent numbers show a nearly \$40 billion increase in public and private health-care spending.

Minnesota spending growth was about the same as the national rate. But the state's per-person spending of \$7,403 was lower than the national figure.

"By historic standards, Minnesota saw low growth in health care spending in 2012," Health Commissioner Dr. Ed Ehlinger said. "However, projections of future spending highlight that we must continue to focus on disease prevention and creating healthy communities if we are going to ensure sustainability of health care costs over the long term."

Ehlinger's department credited several factors for the slower increase, including a waning recession, shifting costs to consumers, slower development of new medical technologies and legal requirements that insurers spend a certain percentage of premiums on health care services.
